On September 17, 2008, our Board of Directors, in accordance with its prior practice, approved the issuance of replacement of certain options that expired unexercised in June, August and September 2008. The new options are exercisable over a 10 year period, for an aggregate of 1,477,000 shares with exercise prices from \$2.20 to \$6.00 per share, the same as the exercise prices for the expired options.
