Capital Group International, Inc. CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 67,573,730 shares or 4.9% of the 1,392,281,432 shares of Ordinary Shares believed to be outstanding.
