On February 27, 2002, Marathon Oil Corporation ("Marathon") entered into an underwriting agreement for the public offering of \$450,000,000 aggregate principal amount of its 6.125% Notes due 2012 and \$550,000,000 aggregate principal amount of its 6.800% Notes due 2032 (the "Notes"). The Notes are to be issued under an Indenture dated February 26, 2002 between the Company and JPMorgan Chase Bank, as Trustee, relating to senior debt securities of Marathon (the "Senior Indenture"). Closing of the issuance and sale of the Notes is scheduled for March 4, 2002.
