We are attempting to determine any changes we need to make to the operating policies that govern how we deal with the funds associated with aged bill payment checks that remain uncashed. These changes would affect our accounting policies with regard to these and other bill pay funds and would impact our financial statements for the quarter ended June 30, 2005 and prior periods back through at least the period beginning July 1, 2003. Until we have reached a definitive conclusion with regard to any changes to our operating and/or accounting policies, we are unable to file our Form 10-Q for the period ended June 30, 2005 without unreasonable effort or expense. We are unable to estimate the impact of any changes to the comparable 2004 period. We anticipate, however, filing the Form 10-Q no later than August 15, 2005 to obtain the relief available under Rule 12b-25(b).
