 - (1) Acquisition of 16,500 shares pursuant to Rule 16b-3 upon payout of 60% (30,000 units) of earned performance share award under shareholder-approved benefit plan. Of these 30,000 units, 16,500 units were paid in shares of Issuer stock, with the remaining 13,500 units paid in cash to cover the reporting person's tax obligations.
