**POWER OF ATTORNEY**

Know all by these presents, that the undersigned hereby constitutes and appoints Victor T. Adamo, Howard Friedman, and Frank O Neil, and each of them, with full power of substitution and/or revocation, the undersigned's true and lawful attorneys-in-fact:
