Statements of the Chairman of the Supervisory Board
at the Annual General Meeting of Linde Aktiengesellschaft
on May 10, 2017 in Munich
(Excerpt)

Before I discuss the report of the Supervisory Board, I would like to say a few words about the situation in the Executive Board when I assumed my office as Supervisory Board Chairman last May.

It is not generally the job or the duty of the Supervisory Board Chairman to comment internal proceedings in the public, however I would like to stray from this tried and tested rule and make an exception today at this AGM, so that you, dear shareholders, get a well rounded idea and picture of the preceding fiscal year.

In the course of the last year, you will have heard that in the public a number of Executive Board Members of Linde had received, I would say, quite contradictory and distorting reports regarding the executive posts at Linde, this was deemed to cause irritation.

The relationship between the long standing CFO, Mr. Denoke, and other Executive Board members, above all the previous CEO, Mr. Dr. Büchele, was not free from conflict. This was obviously also seen and perceived as such in the public eye.

In the summer of 2016 then, the Executive Board of Linde and the U.S. company Praxair, began preliminary negotiations discussing the potential of a merger. And also in the course of these negotiations, we found there were principal and fundamental differences between the CFO and other Executive Board members, especially the previous CEO. The fundamental different perspectives on the Executive Board regarding this potential merger was also obvious for the Linde Supervisory Board. So it became clear to the Supervisory Board that the relationship between the CEO and the CFO required clarification.

At the end of August 2016, the Standing Committee convened and during that meeting, the rift in the Executive Board was debated at length, and one noted that this would hinder massively and impede the factual work of the Company and should therefore be solved as quickly as possible. The Standing Committee therefore recommended to the Supervisory Board on 13th of September 2016 to terminate the cooperation with the CFO immediately. The Supervisory Board took that resolution on the same day and implemented it on the very same day.

So in summary, I can say, that in the Supervisory Board, given the complex situation we received and obtained an all round picture and we also knew there was only one guiding principal in all our decisions: namely that we had to follow the German stock corporation act. Because that makes quite clear stipulations regarding the care and supervisory duties of supervisory boards. Thus, our focus always was to make sure that the entire Executive Board was capable to act and could do so – quite irrespective of a potential merger.

Should Praxair, Inc. (“Praxair”) and Linde AG (“Linde”) proceed with the proposed business combination transaction, Praxair and Linde expect that a newly formed holding company (“New Holdco”) will file a Registration Statement on Form S-4 or Form F-4 with the U.S. Securities and Exchange Commission (“SEC”) that will include (1) a proxy statement of Praxair that will also constitute a prospectus for New Holdco and (2) an offering prospectus of New Holdco to be used in connection with New Holdco’s offer to acquire Linde shares held by U.S. holders. When available, Praxair will mail the proxy statement/prospectus to its stockholders in connection with the vote to approve the merger of Praxair and a wholly-owned subsidiary of New Holdco, and New Holdco will distribute the offering prospectus to Linde shareholders in the United States in connection with New Holdco’s offer to acquire all of the outstanding shares of Linde. Should Praxair and Linde proceed with the proposed business combination transaction, Praxair and Linde also expect that New Holdco will file an offer document with the German Federal Financial Supervisory Authority (Bundesanstalt fuer Finanzdienstleistungsaufsicht) (“BaFin”). There can be no assurance that a binding definitive agreement will be reached between Praxair and Linde, and the consummation of any binding transaction will be subject to regulatory approvals and other customary closing conditions.
